

Third Kingdom Games Art Guidelines and Contract

Artwork

Commissioned artwork shall be created based upon general guidance from the author, and shall not include themes or images deemed offensive or exploitative. Once a piece of artwork is submitted it may be returned for revisions. Once a piece of artwork is accepted payment will be made within 14 days. The rights to the artwork belong to Third Kingdom Games; while the artist is free to post their art for purposes of advertising or a portfolio it cannot be resold.

Dungeon Maps

We pay between 25.00-45.00 per small, 5-10 room dungeons, 50.00-90.00 for medium-sized 11-15 room complexes, and 95.00+ for larger maps. Mapper is expected to label each chamber/area of interest. We use maps with both a gridded scale and those without. Dungeon maps belong to Third Kingdom Games, although the artist is allowed to use the maps for promotional/advertising purposes, they cannot re-sell the maps.

Payment

Payment is made in US dollars via Paypal within one week of receipt and approval of finalized artwork.

AUTHOR & ILLUSTRATOR AGREEMENT

Todd Leback, referred to as “Author”, and _____, referred to as “Illustrator”, agree:

Pursuant to the terms and conditions herein Illustrator shall prepare certain materials to be incorporated in the Work.

Author shall reasonably cooperate with and assist the Illustrator in preparation of the materials.

Pay rate for the work to be determined based upon the above rates *or* agreed-upon negotiations between author and illustrator.

No further compensation shall be due. Author shall have the right to unlimited, universal reproduction of the illustrations thereafter. Illustrator may use the completed work for promotional/advertising purposes but may not resell completed work. Any use of the completed work by the illustrator shall reference “Commissioned for Third Kingdom Games”.

At any point prior to the Author’s deadline, Author may end the project, at which point the project will be considered completed and no further work will be done or paid for, but all work done up to that point will be transferred and paid for. Payment will be made in US dollars via Paypal within one week of receipt of and approval of finalized illustration. Illustrator shall supply the author with an itemized invoice when possible.

Illustrator shall keep the existence of the work, and all information related to the same strictly confidential until the work is published or otherwise is released into the public domain.

Illustrator shall receive credit in any distributed version of the work as the Illustrator, in such places as are customary and usual within the trade for the type of work.

Illustrator warrants that the materials delivered herein are the original work of the Illustrator and that the same do not violate any copyright, trademark, or other protection of intellectual property by Illustrator. Illustrator further warrants that Illustrator has the full right to convey the rights granted to Author herein.

Illustrator shall indemnify the Author from any such claims related to the work of the Illustrator. Provided, however, that in the event that the Author specifically requests in writing a particular form of rendering that the Author shall be responsible for such claims to the extent that they are proximately caused by the Author’s request.

This is the entire agreement between the parties, and the same may only be modified by a writing executed by the parties hereto.
